

# PRIVACY POLICY

Effective on 2025-12-01.

This Privacy Policy describes how Aleksandr Kobozev ("HotAi Lab", "we", "us", or "our") collects, uses, and protects information when you use the HotAi Lab mobile application (the "App" or the "Service").

We are committed to protecting your privacy and processing personal data in a transparent and limited manner.

## 1. Information We Collect

### 1.1 User-Provided Content (Photos and Images)

The App allows you to upload or capture photos and images for the purpose of AI-based image processing.

- Photos are transmitted **only to perform the requested AI processing**.
- We **do not permanently store** photos on our servers.
- Photos are **automatically deleted immediately after processing is completed**.
- Photos are **not used to train, fine-tune, or improve AI models**.
- We do not create user profiles based on photos.

### 1.2 AI Processing (Third-Party Provider)

- AI image processing is performed using Google AI Studio API (Gemini)

- Photos are sent to Google solely to generate the requested output.
- Processing is governed by Google's applicable data processing and security terms.
- Google does not receive data for advertising or AI training purposes from us.

### **1.3 Device and Technical Information**

We may automatically collect limited technical information necessary for the operation of the App, including:

- Device type and operating system version
- App version
- Language and region settings (via expo-localization)
- Crash reports and performance diagnostics

This data does not include precise location data and is not used to identify you personally.

### **1.4 Analytics Information**

We use Amplitude to collect anonymized usage analytics to understand how users interact with the App.

Collected data may include:

- Feature usage events
- Session duration
- General interaction patterns

We do not use analytics data for advertising, tracking across apps, or profiling users.

## 1.5 Push Notifications

We use expo-notifications to send service-related notifications only, such as:

- Processing status updates
- Important service messages

We do not send marketing or promotional notifications.

## 2. How We Use Information

We use collected information solely to:

- Provide and operate the App
- Perform AI image processing requested by you
- Improve app performance and stability
- Deliver service-related notifications
- Comply with legal obligations

## 3. Subscriptions and Purchases

The App offers paid subscriptions processed through Apple's In-App Purchase system.

To manage subscriptions and validate purchase status, we use **RevenueCat**, a third-party service provider that helps us securely manage subscription entitlements and purchase events.

RevenueCat processes limited information related to subscriptions, such as:

- Subscription status and entitlement information
- App-specific user identifiers
- Purchase and renewal events provided by Apple

We do not receive or store your payment card details, Apple ID credentials, or other financial information. All payments are processed directly by Apple.

RevenueCat acts solely as a service provider on our behalf and processes data in accordance with applicable data protection laws.

## 4. Data Retention

- User photos are deleted **immediately after AI processing**.
- We do not maintain backups of user images.
- Analytics and diagnostic data are retained only as long as necessary for operational purposes.
- We do not sell, rent, or monetize personal data.

## 5. Sharing of Information

We share information **only** with trusted service providers acting on our behalf, including:

- Google (Gemini AI processing)
- Amplitude (analytics)
- Expo / Apple (app infrastructure and notifications)

These providers are permitted to use data **only to perform services for us** and in accordance with applicable data protection laws.

We do not share data with advertisers or data brokers.

## 6. Third-Party Services

The App relies on the following third-party services to operate and provide its functionality:

- **Apple App Store** – in-app purchases and subscription processing

The App is not directed to children.

We do not knowingly collect personal data from children.

If we become aware that personal data has been collected from a child without appropriate consent, we will take steps to delete such information.

We implement reasonable administrative and technical safeguards to protect information.

However, no method of transmission or storage is 100% secure.

## **10. International Data Transfers**

Your information may be processed in countries where our service providers operate.

We take steps to ensure appropriate safeguards are in place.
